GENERAL TERMS AND CONDITIONS ARTBOX.PROJECT Barcelona 1.0

1. REGISTRATION

- 1.1 All artists of any nationality can apply, there are no age restriction
- **1.2** The size of the work of art is freely selectable.
- 1.3 The registered artwork must be a work of the artist and he must own all copyrights, this means the artist must have made the artwork himself and it must not be a copy of another artwork from another artist!
- **1.4** All art forms and art techniques are permitted.
- 1.5 No pornographic, racist or ethically unacceptable works will be accepted which .The decision as to whether a work of art is accepted lies solely with ARTBOX.PROJECT. If an **unjustifiable** work will not be accepted, the participation fee will be refunded.
- 1.6 Every artist can submit as many works of art as he likes, for each work of art he has to fill in a form. and pay the entry fee of 45 Euros. The registration deadline is 15 February 2020.

2. WHAT DOES THE ARTIST RECEIVE FOR HIS REGISTRATION?

- 2.1 Every registered artwork for which the participation fee was paid will be shown digitally in a slide show on a big screen during the ARTBOX.PROJECT in Barcelona (March 18 March 22, 2020). Each artwork will be labeled with the artist's name and artwork name plus a personalized QR code, which is designed to allow visitors to directly access the artist's website. However, this requires that the artist fills in the form correctly and without errors when registering. No liability can be accepted for any spelling mistakes made during registration. The duration and frequency of the advertisement can vary and depends on the total number of participants. The paid participation fee is not a rental fee for the screen. No minimum display duration is guaranteed.

 ARTBOX.PROJECTS is in a competition with 10 main winners and 100 semi-finalists, the display of all artworks on the big screen is to be understood as a consolation prize for all non-winners. For possible technical problems, no compensation can be made. In case of technical problems, the organizers will do their best to solve them. The exhibition will take place at Valid World Hall, S.L.C/ Buenaventura Muñoz 6 08018 Barcelona
- The jury will select 10 finalists and 100 semi-finalists for the exhibition in Barcelona. The winners will be notified by email on 20th of February 2020 and published on the website.
- 2.3 The original artworks of the 10 finalists will be exhibited in Barcelona from March 18 March 22, 2020. Each finalist will receive the exhibition space and all related services free of charge, transport costs will also be borne by ARTBOX.PROJECT.

The services are as follows:

- Exhibition area including mounting & suspension of the artwork
- Support by sales personnel during the entire exhibition
- Labelling of the exhibition area according to ARTBOX.PROJECTS standards
- Creation of two personalized QR-codes (Website & Statement Video), which allow visitors to directly access the artist's website with their mobile phone, or to watch the artist's video explaining his artwork.
- Personalized exhibition catalogue with further works of art by the artist
- The artwork of each finalist will be presented on the online platform ARTSY in the ARTBOX.GALLERY profile
 for six months. ARTSY is the second largest online art platform with over 1 million verified buyers, the
 platform is exclusively accessible to galleries. If a finalist artwork is sold during these months via ARTSY, the
 artist receives 100% of the sales price.
- 2.4 The artworks of the 100 semi-finalists will not be exhibited as originals. The artworks of the 100 semi-finalists will be presented digitally on 2 high-resolution screens in the exhibition as a special slideshow. The name of the artist, as well as the name of the artwork will be shown with the picture in this presentation, also a QR-Code will be displayed with the picture, which is there for the visitors to directly access the website of the artist.

- 2.5 All other participants will be shown on the big screen as described under point 2.1
- 2.6 It is up to all participants whether they want to offer their artwork for sale or not. THE ARTBOX.GROUPS GmbH does not take commission on any sale. There is no guarantee that a work of art will be sold.
- 2.7 The transport of the artworks of the 10 finalists to Barcelona and back to the artist will be handled by ARTBOX. GROUPS GmbH. ARTBOX. GROUPS GmbH organizes the transport, only transport costs which are borne by ARTBOX. GROUPS GmbH have been organised or approved. For all sent art works which were not organized by ARTBOX.PROJECT, no liability and no transport costs are taken over.
- An audience voting will take place **during** the ARTBOX.PROJECT in Barcelona. The audience decides which of the 110 artists (10 finalists + 100 semi-finalists) will receive the 1st prize. The 1st prize is cooperation agreement with ARTBOX.GALLERY Switzerland.
- The 110 artists (10 finalists + 100 semi-finalists) will be presented on the website ARTBOX.PROJECTS. The 110 finalists will also be announced on the social media channels of ARTBOX.PROJECTS.
- **2.10** Every artist who has registered will receive a personal certificate of participation in his name, which he is free to publish or attach to his CV.
- **2.11** Every artist who has registered will receive a picture of his artwork on the big screen in Barcelona. The dispatch of the pictures takes place after the art project.

3. SALE OF ARTWORKS BY ARTISTS SHOWN ON THE SCREEN

3.1 All participants are free to release their registered works of art for sale or not. THE ARTBOX. PROJECTS will actively promote the sale of the works shown which are for sale. Each artist can provide us with further information about his or her work of art, which we will then will be passed on to interested visitors. THE ARTBOX. PROJECTS will establish the contact between mediate buyers and artists. The entire selling price goes to the artist, THE ARTBOX. PROJECTS does not charge commission for this service. In particular, each artist can tell us which information about him can be passed on and which not!

4. LEGAL

- **4.1** The artist accepts these terms and conditions with his registration.
- 4.2 The artist declares with his registration that he is the author of the registered work of art and that he has not made a copy of a work of art by another artist.
- 4.3 The copyright of the artwork remains at all times with the artist, ARTBOX.GROUPS GmbH has however the right to publish the artwork on its own website as well as on all social media platforms and to use it for print media referring to the ARTBOX.PROJECT Barcelona 1.0.
- 4.4 No correspondence will be entered into about the audience voting, legal recourse is excluded.
- 4.5 In the event of a discrepancy between a translated version of the General Terms and Conditions and the the original German text shall be valid in the German version.
- 4.6 Should individual provisions of this contract be invalid or unenforceable or become invalid or unenforceable after conclusion of the contract, the validity of the remainder of the contract shall remain unaffected. The invalid or unenforceable provision shall be replaced by a valid and enforceable provision whose effects come as close as possible to the economic objective pursued by the parties to the contract with the invalid or unenforceable provision. The above provisions shall apply mutatis mutandis in the event that the contract proves to be incomplete.
